## President's Report

'Mothers and Daughters in Action 2007' united members in a shared cause to assist, through MaterCare International, mothers-sisters-daughters like us in undeveloped areas, to give birth in conditions medically safe for mothers and babies, to help families enjoy life services we take for granted. Many more women now realize that this is not so for all women in our world and they have responded generously.

At the same time CWL members continue in their branches, parishes and communities to follow the Objects of the League "in working for and building the Kingdom of God" in ways closer to home. This Newsletter, Issue 3 2007, maps and captures in photographs, members gathering together at National Project events and other varied CWL activities across Australia, connecting with and inspiring one another, a reminder of John Paul II in 'Centesimus Annus': "Today more than ever the Word of God will be unable to be proclaimed and heard unless it is accompanied by the witness of the power of the Holy Spirit, working within the actions of Christians in the service of their brothers and sisters, at the points in which their existence and their future are at stake."

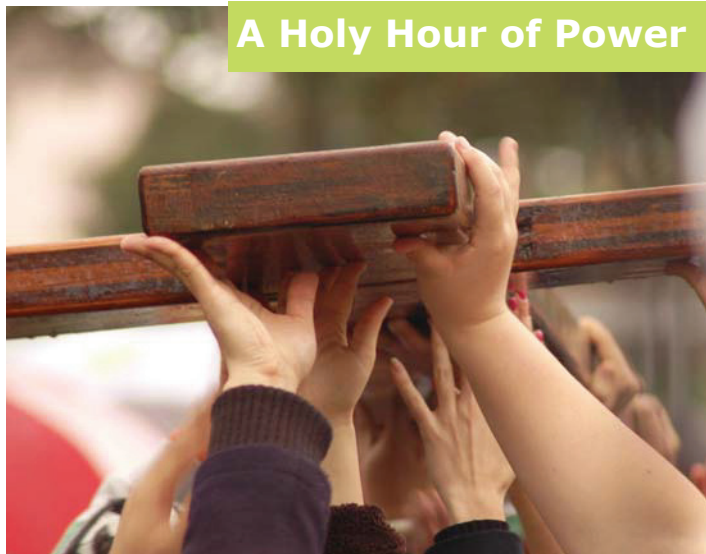

## Social Issues—Betty Roberts

### A Holy Hour of Power



Benedict XVI wants to make the 2008 World Youth Day a great proclamation to young people of God's love. The WYD cross is already on pilgrimage in Australia a symbol of the spiritual journey of conversion and commitment as young people of the world prepare for a meeting of celebration of the faith with the Pope. Prayer is playing a vital role in the variety of preparatory activities occurring throughout Sydney and other national diocese.

On July 20, a year from the day of the final papal mass in 2008, young and old united in St. Patrick's one of the oldest churches in Sydney, for what Auxiliary Bishop Anthony Fisher, dubbed "A Holy Hour of Power".

Following song, Scripture and a personal testimony from Steve Lawrence, ex-professional footballer player - turned WYD director of evangelisation and catechesis, it was Jesus in the Blessed Sacrament who took centre stage

Bishop Fisher recounted the history of St. Patrick's church dating back to the early 1800's when the first Catholics in the nation tried to obtain a grant of land for a church and the government refused the request. When the only priest was expelled by British authorities, he left just one consecrated Host before whom persecuted Catholics gathered secretly for prayer.

"The lay faithful continued to guard and adore Our Lord in the Blessed Sacrament for an entire year until another French priest arrived to offer Mass for them again". Bishop Fisher encouraged Australians to tap into that dedication of our forefathers and revive devotion to God's truth and will.

Benedict XVI's message for World Youth Day appeals to the world's youth "not to forget the great

ness of God's gifts that are the fruits of the Holy Spirit – love, joy, peace, patience, goodness, kindness, faithfulness, meekness and self-control.

As Benedict XVI said "We can only be Christ's missionaries if we allow ourselves to be guided by the Holy Spirit". The Holy Father has requested that we help launch a new Pentecost for the church and humanity in the third millennium.

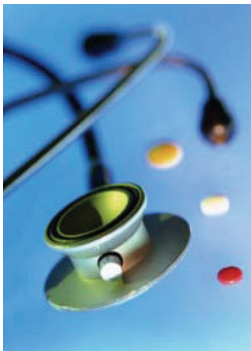
## Bioethics—Margo Nancarrow

### About immunisations

Some people have recently raised questions about the manufacture indeed the whole issue of immunisation/vaccination.

It is true that some vaccines have been developed from a cell line obtained from an aborted foetus. "Three vaccines are grown in commercially available human cell lines that were initially derived from the tissue of two human fetuses who died over 30 years ago in surgical abortions". "The occurrence of these abortions is deeply regrettable. Church teaching would affirm that even though useful vaccines have been developed in cell lines from aborted fetal tissue, this good end can never justify the wrongfulness of the two intentional abortions" (Life Office, Sydney)

Rome has offered advice about the use of these vaccines. (Vatican Pontifical Academy for Life, The Academy urges Catholics and other citizens of upright conscience to use alternate vaccines if these are available or to put pressure on political authorities and health systems so that other vaccines without moral problems become available. If there are no alternative vaccines which are available and ethically acceptable, it is right to abstain from using these vaccines if it can be done without causing children, and indirectly the population as a whole, to undergo significant risks to their health. Morally problematic vaccines may, however, be used ... if not using them would expose others to considerable dangers to their health. This is particularly true in the case of vaccination against German measles.



The Academy states that "...there remains a moral duty to continue to fight and to employ every lawful means in order to make life difficult for the pharmaceutical industries which act unscrupulously and unethically. However the burden of this important battle cannot and must not fall on innocent children and on the health situation of the population – especially with regard to pregnant women."

The Catholic Bishop's Conference of England and Wales dealt with this issue in their 2004 document *Cherishing Life*. An excerpt from part 2 - **Not doing harm, says, (168)**

People also risk causing ill health in others if they carry a disease which could be passed on. There is a common duty to take reasonable precautions not to spread infectious diseases such as measles, chicken pox or influenza. In this context, immunising children against infectious diseases is important not only for their sake, but also to protect other children who would otherwise be at more risk of infection. Vaccination has sometimes been controversial because of a real or perceived danger of side-effects, or because the production of certain particular vaccines has involved the use of tissue taken from aborted foetuses. Parents will want to consider the best evidence available and make a prudent decision on how best to protect their child. Some parents may feel called, on reflection, to boycott vaccines that are linked to abortion, so as to bear witness to the injustice of abortion and to the lack of respect shown to the child's remains. Such actions are neither required nor excluded by justice, but are matters of practical wisdom and personal vocation.

A research paper from Mater Pharmacy Services in Brisbane Mater Misericordiae Hospital, says, regarding use of human cell lines, "This has raised concerns, with reports of some individuals with religious objections to abortion refusing vaccination because they feel this makes them complicit with the original act of abortion. Patients should be aware that cell lines are self-sustaining and additional abortions are not needed to sustain vaccine manufacture. No human cells are actually present in the vaccine, and no abortions are conducted specifically for the purpose of harvesting cell lines. Ethicists at the US National Catholic Bioethics Center have concluded that the association between certain vaccines and abortion was noncomplicit, and thus use of these vaccines is not contrary to a religious opposition to abortion.

Remember that Australia has an effective system for monitoring vaccine safety. Serious adverse events following vaccination are rare, and the risk of morbidity associated with these adverse events is generally far less than the risk from catching a vaccine-preventable disease. Nevertheless, it is extremely important to have in place adequate surveillance for adverse events associated with vaccines. Both the public and health care professionals need to feel confident of vaccine safety.

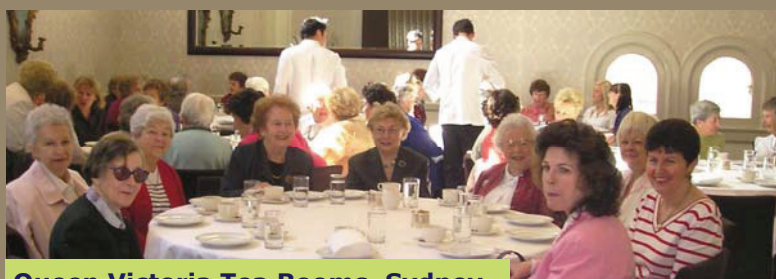

CWL WA Executive members are the masters (mistresses) of multi tasking – but then that is something probably very typical of any CWL member!!

As we look to taking on National 2008-2009 and the preparatory work involved, and continue with the investigation and information gathering for decisions relating to our beloved Downey House and whilst also discussing aspects of our State Constitution, many of our State Councillors could be excused for having split personality traits. It has at times seemed a relentless effort, but we can say with confidence that we have all done our best – and will continue to do so.

Downey House has posed many challenges in decision making and whilst white ant activity is still evident no immediate steps can be taken. Several options for the future have been posed and from these, the Downey House committee will organize a questionnaire and information data to assist with the ultimate decision.

A comment sheet was handed to all State Councillors to assist with the updating of sections of the State Constitution dealing with Life Membership and Diocesan Membership. A motion has now been formulated with the agreed wording and this will go to the State AGM which will take place at the Redemptorist Monastery on 19 October.

Perth Archdiocesan President, Dorothy Beyer, reported on the activities of the Archdiocese in recent months. Dorothy is a representative on the Archdiocesan Committee for Family and for Life. This committee is preparing for a conference named CELEBRATE LIFE – FAMILY – JOURNEY and will include keynote speakers Karen and Jonathan Doyle and Byron and Francine Pirola and also workshops on such topics as Family Communication, Drug Awareness, Teaching Sexuality and Family Liturgy. Due to the closure of some of the "older" branches in the archdiocese the remaining members (sometimes only 1 or 2) have become Diocesan Members. It is interesting to note that many of these members have accepted executive roles on the Archdiocesan council which has in turn enabled them to maintain an active hands-on involvement with the League.

The Archdiocesan AGM was held on Wednesday 22 August in Downey House. A wonderful atmosphere was created by the best turn out of members for several years, many of whom only meet once a year at the AGM. The talk given by Fr Joe Parkinson from

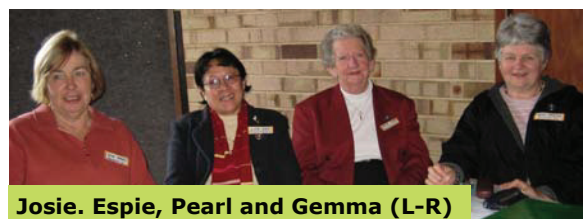

### CONFERENCE NEWS

The 91<sup>st</sup> Annual General Conference of the Catholic Women's League of Victoria and Wagga Wagga held recently in Fairfield, Melbourne was hosted by the Melbourne Archdiocesan Committee. The theme being 'Peace.'

The atmosphere was warm, friendly and very 'chatty' as friendships were renewed.

From the opening Eucharist, Chief Celebrant Bishop Christopher Prowse, representing Archbishop Denis Hart D.D., and concelebrants Fr. Werner Utri, P.P of St. Anthony's Alphington and Fr. Pat. Harvey, Archdiocesan Chaplain, to the closing prayers of the second day, the time spent was informative and rewarding.

During the homily Bishop Prowse drew attention to Mary, Queen and Mother as a role model. Mary praised God in the Magnificat and pondered and treasured things in her heart.

The conference, dinner with entertainment provided by Peter Roberts playing beautiful music on the Harp and a very amusing short play was most enjoyable.

Invited guests present at the dinner were student members from the Victorian Catholic Universities Association.

The conference Guest Speakers were outstanding:

**Fr Daniel Benedetti.** MGL.[ Missionary of God's Love], told a little about his life, then spoke so unassumingly of the wonderful work two Priests and himself are doing with young men, not only spiritually but through sport, discussions, retreats, etc. in the parish where they are working. At present 14 students are studying for the Priesthood.

**Sr Michele Toussaint,** Congregational Leader of the Family Care Sisters spoke of the value of family life and of the care and wonderful support they offer to families requiring assistance. Generous volunteers help with this work.

**Leonie Rastus** from Parish Nurse Ministries, told of assisting parishioners achieve higher levels of wellness physically and spiritually; advising on health and the need for early response to small problems, encouraging healthy lifestyles, making known healthcare and social services in the community.

**Brenda Finalyson.** Vice-President General of the World Union of Catholic Women's Organizations and editor of the magazine Women's Voice, told of the need to be constantly vigilant, especially where the written word may be falsely represented. Brenda's life is extremely full.

**Carmel Eccles.** A very caring, young nurse working at the Alfred Hospital who has spent holiday time working in Vietnam. Carmel told of schools visited; and two orphanages where approximately 200 children are being cared for by only 6 carers. The poverty and lack of funds needed for medical and school requirements greatly restricts the wonderful work being done by so few.

**John Rheinhart,** passed on information about World Youth Day and of 'Days in the Diocese' as overseas visitors arrive. He suggested hospitality as a possible way the Catholic Women's League members may be involved.

**Anna Krohn,** spoke on the Anima Women's Network Inc. This voluntary support network of women enjoy a Memorandum of Understanding with the Catholic Women's League. Their aim is to enrich the lives of women by addressing the issues faced by women in their faith, families, relationships, workplaces and society.

**Several Resolutions were** passed requesting:  
Funding for Pastoral Care,  
Funding for Pregnancy Support.  
Affordable rental housing to be made available.  
More affordable housing to be made available for purchase (With good financial counselling accessible)

Fairer costing for gas supplied and individual metres fitted to high rise residences.

Members are asked to write to Members of Parliament requesting suitable action be taken on these resolutions.

The Archdiocese is to be congratulated on a successful conference. Much hard work and preparation is involved both before and during the two days, to ensure the time table is pleasantly adhered to and the conference enjoyed by all.

Please pray continually for respect for life. Bishop Prowse said in his homily the most dangerous place for a person to be today is in the womb.

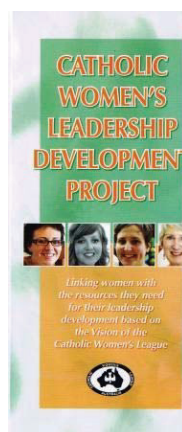
#### CATHOLIC WOMEN'S LEADERSHIP DEVELOPMENT PROJECT

## Canberra/Goulburn

This month saw a disaster for our Archdiocese and especially the O'Connor Branch of Catholic Women's League and other parishioners, with the burning of St. Joseph's Church O'Connor, ACT and the destruction of the Parish Centre. But the Miracle of the saving of the Altar and its Cloth, the Tabernacle, and the Picture of Blessed Mary McKillop, and the Irish stained glass, among other things, were a blessing. ### CWLA's National Project: 'Mothers and Daughters in Action 2007'

was supported wholeheartedly by members and friends across Australia and we appreciated the assistance of Dr Elvis Seman during the term of the project. A cheque for \$75,280 was presented to Dr Adrian Thomas, Chairman MaterCare Australia and MaterCare International (as pictured below). We were privileged that Dr Adrian was able to be present at CWLA's 43rd National Biennial Conference. In his address, reported here by Pat Walker: he told us that MaterCare and CWL can achieve a lot. The solution to safe motherhood is not abortion but trying to breathe life back into motherhood in countries where women still die in child-birth. MaterCare focuses on hospitals and emergency transport service to get women there. Some governments think that abortion and sterilisation is the help needed but the people don't want this. East Timor is desperately short of everything and in Africa many refugees are not receiving help. In war and conflict women and children suffer the most.



...and from Dr Rob Walley, Executive Director, MCI: Mothers and women throughout the world are suffering from violence from commission, e.g. abortion, genital mutilation, sexual assault but also from violence from omission, e.g. the failure to provide adequate care especially during pregnancy and child-birth, care for those with obstetric or traumatic gynaecological fistulae (arising from gang rape and physical torture in conflict situations e.g. in Rwanda 1994 and presently in Darfur and the Democratic Republic of Congo); and also from omission when information is kept from women and they make the wrong decision about continuing their pregnancy. The solution offered by the international health community known as reproductive health (the euphemism for abortion and birth control) dominates international women's health care. If I may put aside for the sake of argument, these are irrelevant when a mother is dying from obstructed labour or post-partum haemorrhage or is incontinent due to fistulae. The Millennium Development Goals especially No 5 concerning improving maternal health by reducing maternal mortality and morbidity are not being met. A recent article in the British medical Journal (July 14th 2007), points out that "at the present rate of progress No 5 will take 275 years to be reached! MCI's position is that these problems related to women's health will only be solved one woman at a time. Women in rich countries have access to the best of care. MCI, working with the bishops in Africa is trying to provide some sort of care for very poor mothers. However, we also must be there for the mothers in distress in our own countries to provide them with care based on life and hope.
